### Prof. A.D. Shinde Research Fellowship Award 2020-21 Guidelines

The primary aim of Prof. A.D. Shinde Research Fellowship Award is to promote research among the young faculty members and research scholars of ICA.

#### 1. Eligibility for the Grant / Award

- 1.1Candidates who are Permanent/Regularly employed as faculty in the rank of assistant professor in a UGC recognized

  University/College/Institution/affiliated institution are eligible for this grant. It should be duly certified by the Principal of the College.
- 1.2Scholars from other professions like civil servants, journalists, and industrialists etc. who hold Ph.D Degree and have a keen interest in research are also eligible for this grant.
- 1.3The applicants who are currently working on minor/major projects/ similar fellowship/grants sanctioned by UGC/ICSSR/other similar institutions cannot submit the same/ similar proposals for this Grant
- 1.4This grant is available for candidates below the age of 35 years.
- 1.5Only one person is eligible for the Grant-in –aid.
- 1.6The Applicant should be a Life Member of ICA.

#### 2. Duration and Value

- 2.1Duration of the research project is 12 months.
- 2.2The research project will be allotted at the time of Annual Conference of ICA.
- 2.3The maximum budget that may be allotted to the candidate is Rs. 50000

#### 3. Submission of proposal (10 Hard Copies)

10 Copies of the duly filled in Applications along with the Research proposal and other documents should be submitted in hard copy only latest by 31st May 2021 to the Secretary, ICA at the following address:

The proposals should be forwarded through the Head / Principal

#### 4. Procedure for selection

- 4.1The proposals complete in all respects shall be reviewed by a 3-member expert committee where two members will be appointed by the President and Secretary, ICA and one member will be appointed by Donors or their representative
- 4.2The broad outline of the selection criteria is as follows

4.3The information regarding the award to the selected candidate will be given through e-mail to the Conference Secretary and will be announced at the time of the conference.

#### 5. Release of Grant

- 5.1The sanctioned grant will be released in two instalments.
- 5.260% of the sanctioned grant will be released within a month of the award of the research fellowship in the name of the candidate.
- 5.3Remaining 40% of the amount will be released after the submission of the final report and the presentation.

#### 6. Progress report

6.1The recipient of the awardee will be required to give an interim presentation of the research work after 6 months through email.

#### 7. Submission of Final Report

- 7.1The awardee is required to submit three copies (two hard copies and one soft copy) at the Annual Conference.
- 7.2The report will be evaluated by an expert of the ICA specialized in the field to be appointed by the President, Secretary, ICA and Representative of Donor.
- 7.3If the expert is satisfied with the research report, the remaining balance of the award may be released by the Secretary.
- 7.4The awardee will make a 10-minute presentation on the findings of the research project at the final of the BBAY Awards presentation.

#### 8. General Guidelines

- 8.1Extension in tenure is not permissible in any circumstances.
- 8.2If a Investigator fails to complete the project, he/she has to refund the entire amount sanctioned with interest.
- 8.3 Certificate regarding plagiarism shall be included in the final report.
- 8.4The research report shall be in English
- 8.5The final report shall be uploaded on the website of Indian Commerce Association.
